# 先進諸国の国際政治経済

80年代以降の国際政治経済の顕著な特徴に多様な形態の地域経済協秩序の増大と多角的貿易・通貨・金融秩序の変容がある。本講は、このような変化をどのように統一的に説明できるかを検討する。その際、まず、通説的な国際システムレベルでの政治変動、特にアメリカ覇権の衰退に依拠する説明の限界を確認し、次いで、為替変動と資本移動増大という国際経済のシステムレベルの変動への対応しての米国とその他の国々の対外経済政策の作用の結果という視点の有用性を議論する。以上の過程で経済政治経済に関する主要な業績を再検討し、最近の事例を概観する。演習参加者にはこのような作業を通して分析枠組を構築する修練を積んで頂きたい。
