先進諸国の比較政治経済

石油危機以降の先進諸国経済の最も顕著な特徴はインフレ率の低位収斂とそれに伴う失業の増大や財政 緊縮の要請である。このゼミは、国際的資本移動の制約下の各国のディスインフレ改革の態様を協調的 賃金決定と民主主義類型とで類型化ことができるかの関心のもと、経済国際化の国内的影響の関する先 端的業績を吟味する。更に、このような作業を通して分析枠組構築の修練を積む機会を参加者には提供 したい。今年は特に国際資本移動の制約下の財政改革と雇用・福祉改革に焦点を当て、事例としては日 本とドイツの近接比較の理論的含意を検討する。
